In lieu of granting leave to appeal, pursuant to MCR 7.205(D)(2), the Court orders that the November 24, 1999 order of the Wayne County Circuit Court is VACATED and the matter is REMANDED to the trial court for reconsideration of its ruling that the Notice and Order of Prohibition issued by the Office of Financial and Insurance Services on December 16, 2005, rendered Rory v Continental Ins Co, 473 Mich 457; 703 NW2d 23 (2005) inapplicable. In reconsidering this issue, the trial court shall examine McGraw v Farm Bureau Gen Ins Co of Michigan, 274 Mich App 298; 731 NW2d 805 (2007) and McDonald v Farm Bureau Ins Co, 480 Mich 191; 747 NW2d 811 (2008), which were not cited by the parties below or on appeal. The trial court shall also consider the recent decision of Ulrich v Farm Bureau Ins, ____ Mich App ___; ___ NW2d ___ (Docket No. 289467, released April 29, 2010) slip opinion.
