Re: **Nelson Templeton v Loretta Templeton**

William B. Murphy, Chief Judge, acting under MCR 7.203(F)(1), orders:

The claim of appeal is DISMISSED for lack of jurisdiction because the August 25, 2011, postjudgment order requiring payment of health insurance costs and alimony is not a final order as defined in MCR 7.202(6)(a)(i). MCR 7.203(A)(1). To the extent that the appeal is taken from that portion of the postjudgment order that denies defendant's request for attorney fees and costs, this Court lacks jurisdiction of the appeal because plaintiff is not an aggrieved party from that portion of the order. MCR 7.202(6)(a)(iv); MCR 7.203(A). At this time, plaintiff may seek to appeal the August 25, 2011, order only by filing a delayed application for leave to appeal under MCR 7.205(F).
