In lieu of granting leave to appeal, pursuant to MCR 7.205(E)(2), the Court orders that the Oakland Circuit Court's decision to require defense counsel to notify plaintiff at least 24 hours before any ex parte interview with plaintiff's treating physicians and health care providers is REVERSED and the language of the fourth paragraph of the circuit court's November 14, 2014 qualified protective order requiring such notice is STRICKEN from the qualified protective order. Szpak v Inyang, 290 Mich App 711; 803 NW2d 904 (2010). Plaintiff's desire for notice can be accomplished through traditional methods of discovery. MCR 2.309; MCR 2.302(E)(1)(b)(ii), (c).
