By order entered on August 8, 2016, Court Reporter Lisa C. Schuel (CER 6707) was ordered to file the outstanding transcripts for this appeal by Friday, August 12, 2016 at noon. Court Reporter Lisa C. Schuel's August 11, 2016 letter to the Court is treated as a motion to extend time to file transcripts and is GRANTED in part.

The outstanding transcripts for September 15, 2015, September 17, 2015 and September 18, 2015 must be filed in the trial court with a notice of filing transcripts provided to this Court by 5:00 p.m. on Friday, August 12, 2016. If the 5:00 p.m. deadline is not met for the transcripts of September 15, 2015, September 17, 2015 and September 18, 2015, a bench warrant will issue Monday, August 15, 2016 at 9:00 a.m.

The outstanding transcripts for October 2, 2015 and January 11, 2016 shall be filed in the trial court with a notice of filing transcripts provided to this Court by 5:00 p.m. on Monday, August 15, 2016. If the 5:00 p.m. deadline is not met for the transcripts of October 2, 2015 and January 11, 2016, a bench warrant will issue on Tuesday, August 16, 2016 at 9:00 a.m.

It is further ordered that Court Reporter Lisa C. Schuel (CER 6707) shall pay on Monday, August 15, 2016, the outstanding filing fee of \$100 for her motion to extend time to file transcripts; payment shall be made to the Court of Appeals at one of the Court's district offices or by e-filing. Payment may not be made by "overnight" mail or in any other manner.

This Court further reaffirms its August 8, 2016 order, requiring Court Reporter Lisa C. Schuel (CER 6707) to pay a fine in the amount of \$500 within 21 days of the date of that order, which is August 29, 2016. Additionally, this Court reaffirms its August 8, 2016 order assessing Court Reporter Lisa C. Schuel (CER 6707) \$50 per day for each day between August 8, 2016 and the date of the filing of the last outstanding transcripts with the trial court. Those assessments are due 21 days after the last outstanding transcripts are filed with the trial court.

A copy of this order shall be furnished forthwith to the Michigan Court Reporting and Recording Board of Review, to the chief judge of the Kalamazoo Circuit Court, and to Kalamazoo County Probate Judge Tiffany Ankley.
